THE PATRON ACKNOWLEDGES AND AGREES AS FOLLOWS:

1) I am over the age of 15 years. 2) I have read and fully understand the rules of paintball and I agree to abide by those rules during my participation. 3) SOP will ensure that paintball games are managed and operated with due care and skill and that the equipment and materials used are fit for the purpose for which they are supplied. Otherwise I use the services and materials and participate in the said games entirely at my own risk as I find and with prior knowledge of the dangers. 4) I agree to indemnify SOP against all actions, proceedings, claims, demands, cost and expenses in respect of or any way arising out of my negligence or my failure to abide by the Rules of Paintball. 5) I will wear facemasks at all times during the course of the game and only remove when advised by staff that it is safe to do so. 6) I am aware that participation in paintball games may be hazardous and result in injury or death. Injury may include bruising, sprains, strains, dislocations or fractures, bites and stings; eye injury may be incurred if facemasks are removed during games. Running, walking backwards, diving, climbing or jumping will increase the risk of injury. 7) I acknowledge a risk of loss or damage to my clothing and personal property. SOP shall not be responsible for such loss or damage. 8) The loss or damage of any paintball equipment is the legal responsibility of the participant. 9) I acknowledge that there is a requirement before play to bring to the attention of SOP staff any impairments or disabilities physical, psychological or otherwise that I have. SOP is entitled to make an assessment of my condition or impairment before play and reserves the right to disallow participation based on the potential safety issues involved. 10) SOP has advised me that a medical practitioner should be consulted as to any health issues prior to participating in paintball games. 11) My exertion in participation in paintball games at SOP will be appropriate to my fitness level. If unsure of safe exertion level for my fitness level, I will not participate in paintball games. 12) In the event of injury, SOP reserves the right to call an ambulance on my behalf, at my cost. 13) I am not a prohibited person as defined by the Weapons Act 1990 (Qld). 14) I agree to pay any charges I incur whilst attending the SOP venue. 15) I agree to allow SOP and its affiliates including Wanrooy Entertainment Pty Ltd to contact me regarding promotional offers and to use my personal information, images, video and audio recordings of me at their facilities for their commercial, marketing and research purposes without restriction and without any form of compensation to me. 16) SOP retains the right to withdraw permission to the participant to continue in the game at any time. 17) Paintballs is completely non-refundable and any loss or damage to paintballs will not be reimbursed by the venue. Paintballs are NON REFUNDABLE. 18) As part of its game play, SOP might provide slingshots and sledgehammer for its players to use. Slingshots and sledgehammer are not toys and SOP will not be held responsible for any injury or accidents caused by the use of slingshots and sledgehammer during game play.

INDEMNITY TO WANROOY ENTERTAINMENT PTY LTD AND SPEC OPS PAINTBALL

In consideration of my participation I agree to indemnify SOP in the following manner:

19) Participate in the activity at my sole risk and responsibility and agree to hold harmless SOP with respect to any injury or property damage suffered by me or caused by me to any other person whether arising from any negligence on the part of any servant or agent of SOP or from any other cause. 20) I accept the venue as it stands with all or any defects hidden or exposed. 21) I hereby indemnify and shall keep indemnified SOP, its servants, agents officials against any action or claims which may be made on my behalf or by other parties for or in respect of or arising out of my death or any injury, loss or property damage caused by my equipment whether caused by negligence, breach of contract or in any other manner whatsoever.

PLAYING AND SAFETY RULES

CONDUCT

- Players must wear facemasks at all times. Removing them only when instructed by referees.
- Players must at all times have both hands in contact with the paintball marker (with the exception of reloading or if you are holding a playing shield or sledgehammer).
- All safety equipment provided by SOP must be worn at all times.
- Players must not deliberately shoot at the netting, fire alarms, switches on post or lights, or at the head or face of other players.
- Players must strictly observe all safety signage and referee instructions.
- No marker may be discharged or taken into any safe area.
- Participants or visitors displaying unsportsmanlike conduct, abusive or violent behavior towards other players or staff will not be tolerated
- No dangerous objects, lighters or matches are permitted on the playing fields nor are any food or drinks.

GAMES

- Eliminated players - when tagged by a paintball, raise your marker, arm or both in the air above your head and quickly move out of the playing area.
- Follow referees instructions.
- DO NOT REMOVE YOUR FACEMASKS.
- During games players must remain within designated game (playing field) areas.
- Players must not fire upon another person under a distance of 6 meters.
- All injuries are to be reported to a referee or staff member immediately.

EQUIPMENT

- Staff must inspect privately owned facemasks or markers and approve before use.
- Do not disengage any safety features of the equipment unless instructed by a referee.
- DO NOT REMOVE FACEMASKS FOR ANY REASON WHILST IN A PLAYING AREA.
- Please respect the equipment you have hired from us.
- Paint is completely non-refundable and non-transferable and under no circumstances will unused paint be taken back after purchase.
